

# MUNRO TOWNSHIP BOARD MEETING MINUTES

June 12, 2007

The meeting was called to order by Supervisor Antkoviak at 7:30 p.m. at the Munro Township Hall.

MINUTES – Mandrick made the motion to accept the May 8, 2007 meeting minutes as presented, supported by Dotski. Motion carried.

PAYMENT OF BILLS – Mandrick made the motion to pay the May bills amounting to \$10,139.75, supported by Dotski. Motion Carried.

## CORRESPONDENCE

1. Cheboygan County Treasurer asked if Munro Township was interested in first bid on property located on Douglas Lake Road which is up for back taxes. The property has to be used for public purposes only. Ginop made the motion to not accept the first bid offer, supported by Mandrick. Motion carried.
2. Letter from Senator Jason Allen replying to Linda Ginop's letter about eliminating Township assessor's duties, elections and tax collections and giving the duties to the Counties.

## PUBLIC COMMENTS

Mr. Dennis Lennox, Chairman of Citizens Against New Taxes talked about the Cheboygan County Recycling Program. He is not against recycling but is against the \$25.00 annual surcharge to be placed on every household/dwelling in the county. He believes there should be an election so every registered voter can have a say on the matter.

County Commissioner, Linda Socha explained the process that the Recycling Committee did before they came to the Cheboygan County Commissioners for approval. Linda has talked to people and she had positive feedback on the subject. The county would like to have the program approved by the townships as soon as possible so it could be on the tax rolls for this year. If there was an election, it would mean another year before the recycling program could be started. Mr. Frank Zurawski said he for in favor of recycling but the people need to be educated first.

## OLD BUSINESS

1. Board of Review Appointments to fill Dale Dotski's place. Matthew Bonnett will be a regular member while Dale Dotski will serve as an alternate. Ginop made the motion to appoint Bonnett and Dotski, supported by Mandrick. All favored saying "Aye". Motion carried.

## NEW BUSINESS

2. Ginop asked that \$35.00 be charged for using the township hall for funerals.
3. County Commissioner Linda Socha asked the Board how they felt about changing the County Road Commissioners from 3 to 5 members. Munro agreed that there should be 2 more members. The added change of members will be on the ballot.

Mandrick made the motion to adjourn the meeting, supported by Antkoviak. The meeting was adjourned at 8:40 p.m.
