INSTRUCTIONS FOR APPLICANTS FOR ABSENT VOTER BALLOTS

Step 1. After completely filling out the application, sign and date the application in the place designated. Your signature must appear on the application or you will not receive an absent voter ballot. Step 2. Deliver the application by 1 of the following methods: (a) Place this application in an envelope addressed to the appropriate clerk and place the necessary postage upon the return envelope and deposit the envelope in the United States mail or with another postal service, express mail service, parcel post service, or common carrier. (b) Deliver the application personally to the office of the clerk, or to an authorized assistant of the clerk. (c) In either (a) or (b), a member of the immediate family of the voter including a father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law, grandparent, or grandchild or a person residing in the voter's household may mail or deliver the application to the clerk for the applicant. (d) In the event an applicant cannot return the application in any of the above methods, the applicant may select any registered elector to return the application. THE PERSON WHO ASSISTS THE VOTER MUST FILL IN AND SIGN THE CERTIFICATE BELOW AND RETURN THIS ENTIRE FORM IN PERSON TO THE CLERK'S OFFICE.

WARNING: A person making a false statement in this absent ballot application is guilty of a misdemeanor. It is a violation of Michigan election law for a person other than those listed in the above instructions to return, offer to return, agree to return or solicit to return your absent voter ballot application to the clerk. An assistant authorized by the clerk who receives absent voter ballot applications at a location other than the office of the clerk must have credentials signed by the clerk. Ask to see his or her credentials before entrusting your application with a person claiming to have the clerk's authorization to return your application.
