The meeting was called to order by Supervisor Antkoviak at 7:30 p.m.

Mandrick made the motion supported by Dotski to accept the June 10, 2008 meeting minutes. Motion carried.

CORRESPONDENCE

- Kevin Elsenheimer State Rep for 105th District asked each township to make a
 resolution pertaining to the State Revenue sharing formula. At present, Detroit
 receives 52% of revenue sharing although they have only 10% population in the
 state. New proposals would make payments on a per capita basis, giving Munro
 Township over \$30,000 per year more.

- 3. A DEQ permit was granted to Marian Warren of Douglas Lake to place rock rip-rap on her shoreline.
- 4. Burt Township is receiving high speed internet through Racc2000
- FEMA is going to map Cheboygan County for a flood plan. Ginop will ask Marcia Rocheleau if there is going to be another FEMA meeting to attend.

OLD BUSINESS

Discussion on whether or not to stain the hall floor. The floor is not oak like the molding. It was discovered that three stair treads were missing, Ginop will check with Northern Hardwoods Products who delivered the materials to the hall.

Brine was not spread on Indian Trail Road; Antkoviak will take care of the matter.

NEW BUSINESS

A resolution was made that Munro Township wants the State of Michigan to change their current Revenue Sharing formula to a per capita basis, therefore giving townships, cities and villages more money than Detroit. The foregoing resolution was made by Ginop and supported by Antkoviak to have State Revenue Sharing based on per capita. Upon roll call

vote, the following voted "Aye": Mandrick, Dotski, Antkoviak, and Ginop. "Nay": none. The Supervisor declared the resolution adopted.
