October 13, 2009

The meeting was called to order by Supervisor Antkoviak at 7:30 p.m. at the Munro Township Hall. Pledge to the flag was recited.

Motion by Tracey, supported by Mandrick to accept the minutes of September 10, 2009 with the correction that Gerald & Lisa Atherholt recommended Mackinaw Art & Sign instead of Marie Watts to quote a cemetery sign for the township.

A motion was made by Tracey, supported by Mandrick to pay the bills amounting to \$3,542.49. Motion carried.

NEW BUSINESS

- 1. Cemetery lot transfer from Roger Caldwell to Michael Roy.
- 2. Mackinaw Art & Sign submitted cemetery sign designs. It was discussed that the clerk gets a couple of quotes before next meeting.
- 3. Mandrick reported that several residents on Munro Lake asked about seal coating Munro Lake Drive. Seal coating does not hold up and Munro Lake Drive would need ditches and culverts. Most residents would not approve having ditches on their property. Mandrick also asked about a Blight Ordinance either for the township or county. To have a Blight Ordinance, you must have an enforcement officer, the county does not have money to police these blight properties.

OLD BUSINESS

- 1. The community swimming pool meeting was held September 14, 2009, Antkoviak attended the meeting. An engineering proposal is proposed, the proposed site being at the Cheboygan Sports complex.
- 2. MDOT will have a meeting at the Cheboygan County Road Commission garage on Oct. 22, 2209 at 9:00 a.m. to review current and future projects.
