1. NEMCOG asked that each township pass a resolution in opposition of Michigan Natural Resources Trust Fund dollars being diverted to fund state projects and send it to the State officials.

3. Attorney Tim MacArthur sent a draft of the Resolution of Intent for Participating in the National Flood Insurance Program and a Joint Resolution and Intergovernmental agreement to manage floodplain development for the national flood insurance program.

2. Ginop reported that Gail Passino, George and Bonnie Quick and Nancy Cemezar pulled weeds and sprayed Roundup at the fire hall. Clay Ginop will spray the weeds growing in the driveway. Ginop asked that mulch be purchased for the flowerbeds. Spray's Nursery quoted \$42.00 per yard delivered; Ginop Construction can deliver from Northern Michigan Hardwoods for \$25.00 per yard. Tracey made the motion to purchase 10 yards mulch from Ginop Construction for \$25.00 per yard, supported by Mandrick. Motion carried.

3. Ginop reported that new electronic poll books would be used for the primary election.
4. Bob Watts from Pells Island Drive asked that the road be graded before brine is laid.
