# MUNRO TOWNSHIP BOARD MEETING

September 11, 2012

Supervisor Antkoviak called the meeting to order at 7:30 p.m. at the township hall. Pledge to the flag was recited.

MINUTES – Mandrick made the motion to accept the August 14, 2012 meeting minutes as presented. Dotski supported the motion. Motion carried.

BILLS – Motion by Mandrick, supported by Dotski to pay the August bills amounting to \$4,586.30. Motion carried.

#### CORRESPONDENCE

- Steve Schnell, Community Development Director of Cheboygan County asked for township participation on the County Master Plan. A date of Oct. 2nd or October 23<sup>rd</sup> is being considered for a joint meeting with Hebron, Mackinaw and Munro Townships. October 23<sup>rd</sup> was the choice for Munro Township.
- 2. Form L-4029 for the 2012 Tax Rate Request was sent to each township to be presented to the County. Antkoviak reported that the County said Munro had to levy the .75 mills that voters approved at the August Primary election for fire protection. Attorney MacArthur wrote up the wording stating Munro could levy just enough millage to pay the current year fire fees. Antkoviak was taking the ballot-wording proposal to the County for review. (The levy will be .55 mills).
- 3. DEQ Permit was granted to James Hodgson for shoreline protection.
- 4. Jerry and Lisa Atherholt asked about installing hidden intersection signs on both the Southbound and Northbound areas on Heilman Road where Hayward Road dead ends at Heilman Road. They said the area is very dangerous. Ed Ginop said the big tree blocks motorists view, drivers need to be very careful. Antkoviak is going to a CCRC meeting and will ask the Road Commission about a sign.
- 5. DEQ Munro Township is now enrolled in the FEMA National Flood Insurance Program.
- 6. NEMCOG is hosting a seminar on Economic Growth for Pure Michigan, October 3, 2012, 12:00 2:00 p.m. at the University Center in Gaylord.

#### **OLD BUSINESS**

Several neighbors are complaining about Mr. Roger Skrobeck blocking off the two-track trail going across his property. Supervisor Antkoviak said he'd talk to Mr. Skrobeck in person.

## NEW BUSINESS

Marie Watts asked the board why the County is not grading her road (North Extension). Antkoviak said North Extension is a Primary County Road and the CCRC is not grading any roads because they are working on other roads.
