# MUNRO TOWNSHIP BOARD MEETING MINUTES

September 13, 2016 Meeting held at the Munro Township Hall

Supervisor Antkoviak called the meeting to order at 7:30 p.m. with the pledge to the flag.

**Minutes –** Tracey made the motion to approve the minutes of August 9, 2016 meeting, support by Nows. Motion carried.

**Payment of Bills –** Nows made the motion to pay the August bills amounting to \$4,205.82, supported by Tracey. Motion carried.

## Guests

- 1. Dan Socha, Fire Chief of Inverness Fire Department asked if the township would pave fire station #2. The gravel drive brings in a lot of dirt from the truck. Ginop will get two quotes from Reith-Riley and Sperling. Dan also reported the air conditioner is not working. Ginop will get Werner's Plumbing & Heating to check out the system.
- 2. Amber Libby is running for Cheboygan County Clerk, she handed out her qualifications and asked for any support in the November election.
- 3. Gene Hodulik, Burt Twp Trustee and board member of the Burt Recreation Trail. Gene thanked Munro Township for their participation and financial support; he said the extra support will help with grant writing. Dan Socha suggested adding mile markers on the trail in case someone needed emergency rescue. Tim MacArthur, attorney for both townships wrote an Inter-Township Agreement for Extension of Recreational Trail, Ginop made the motion to accept the Inter-Township Agreement, supported by Antkoviak. Motion carried. Both Supervisor and Clerk signed the agreement.
- 4. County Commissioner, Chris Brown reported that the County hasn't decided what to do with the 3 million dollars it will take to improve the County Marina.

- 1. Ashley O'Reilly who lives on Douglas Lake Road asked that the June meeting minutes be corrected, she did not purchase flood insurance. The Walkway Lane is not a driveway; it is a 20 foot wide walkway and is a deeded access walkway meant for those in the subdivision to use to access the lake.
