**Regular Board Meeting**

**Board Members Present:** Mary Bur, Donald Tracey, Charles Antkoviak, Paul Nows. Cheryl Dotski was absent.

Supervisor Antkoviak called the meeting to Order at 7:00 PM with the Pledge to the flag.

**Minutes:** Donald Tracey made the motion to approve the December 10, 2019 meeting minutes. Supported by Paul Nows. Motion carried.

**Payment of Bills:** Paul Nows made the motion to pay the bills in the amount of \$7,920.31. Supported by Donald Tracey. Motion carried.

**Correspondence:** Supervisor Antkoviak received a Land Division Application from Kenneth & Veronica Budzinski, the Supervisor has reviewed the request and has verified that it meets all the proper requirements. A Motion was made by Antkoviak to approve the application with the stipulation that the parties remit the additional \$5.00 application fee due to the Cheboygan County Treasurer. Supported by Trustee Nows. Motion Carried.

**New Business:** Supervisor Antkoviak advised that Richard Geddert would like to be removed from the Board of Review. Supervisor Antkoviak made a Motion that Dale Dotski be appointed to replace him. Supported by Trustee Nows. Motion Carried. Clerk Bur will have him sworn in at the next meeting and advised that he will need to attend training.

A Motion was made by Clerk Bur to adopt the 2020 Township Board Meeting Calendar. Supported by Trustee Tracey. Motion carried. Please note that there are several months in which the meeting date has been changed from the traditional second Tuesday of the month to accommodate the upcoming 2020 elections.

**AFFIDAVITS,** a Motion was made by Antkoviak and supported by Bur to adopt the resolution. Upon roll call, the following voted: "Aye": Antkoviak, Bur, Nows & Tracey. "Nay": none. The Supervisor declared the resolution.

Fire Chief Socha addressed the Board to announce that he will be retiring in February of 2020. He has requested that the Board consider replacing the automatic door openers in each bay as they are outdated and not properly functioning, the cost will be approximately \$2,500.00 for the two doors. Clerk Bur made the Motion that we approve having the doors replaced. Upon roll call, the following voted: "Aye": Antkoviak, Bur, Nows & Tracey. "Nay": none. Motion carried.

The Chief also stated that an updated exhaust system is necessary in the bay area of the fire hall; Clerk Bur asked that he get an estimate so that we know what type of dollars they are requesting.

Clerk Bur made the Motion that for the purpose of transparency that all future publications made on behalf of the Township be published in the Cheboygan Daily Tribune. Upon roll call, the following voted: "Aye": Bur, Nows & Tracey. "Nay": Antkoviak. Motion carried.
