Supervisor Ginop called the meeting to Order at 7:00 PM with the Pledge to the flag.

Agenda: Don Tracey made the motion to approve the March 2026 Meeting Agenda, supported by Al Antkoviak. Motion carried.

Approval of Minutes: Don Tracey made the motion to approve the February 2026 Regular Meeting Minutes and Budget Workshop Minutes, supported by Keith Ginop. Motion carried.

Payment of Bills: Cheryl Dotski made the motion to pay the March 2026 bills in the amount of \$46,980.57 supported by Al Antkoviak. Motion carried.

- Motion by Keith Ginop supported by Don Tracey to adopt the Munro Township 2026/2027 Budget. Upon roll call the following voting aye: Bur, Dotski, Ginop, Tracey and Antkoviak. Voting nay: none. The Supervisor declared the Motion Adopted.
- Motion by Keith Ginop supported by Don Tracey to adopt the Inverness Fire Department 2026/2027 Budget. Upon roll call the following voting aye: Bur, Dotski, Ginop, Tracey and Antkoviak. Voting nay: none. The Supervisor declared the Motion Adopted.
- Motion by Mary Bur supported by Don Tracey to adopt the 2026/2027 Municipal Retainer Agreement with Attorney Timothy MacArthur. Upon roll call the following voting aye: Bur, Dotski, Ginop, Tracey and Antkoviak. Voting nay: none. The Supervisor declared the Motion Adopted.
- Motion by Keith Ginop supported by Don Tracey to approve Nick Stage; Stage 4 Property Maintenance to the 2026 Cemetery (and Hall) Spring Clean Up to include a \$50.00 per cut increase for mowing. Upon roll call the following voting aye: Bur, Dotski, Ginop, Tracey and Antkoviak. Voting nay: none. The Supervisor declared the Motion Adopted.

- Motion by Mary Bur supported by Keith Ginop to appoint Charles Antkoviak as an alternate for the Munro Township Board of Review. All in favor. The Supervisor declared the Motion Adopted.
- Motion by Don Tracey, supported by Al Antkoviak that we accept three bids for the Township for \$37,500.00 worth of Afton Stone. All in favor. The Supervisor declared the Motion Adopted.
- Supervisor Ginop discussed moving \$200,000.00 from General Savings into CD's to earn future road fund monies. Treasurer Dotski will compare rates.
- In regards to the Cemetery, Supervisor is looking into plotting 15 new lots in Potter's Field, purchasing an 8x10 storage building with a cement pad floor. The stone pillars at the entrance of the cemetery need to be replaced or fixed.

2nd Public Comment: County Commissioner Jeff Ostman addressed the group with local county updates to include the continued clean up from the 2025 Ice Storm. Discussion was held in regards to the Board of Review and procedures.
