April 14, 2026

Board Members Present: Mary Bur, Cheryl Dotski, Keith Ginop(late), Don Tracey and Al Antkoviak.

Clerk Bur called the meeting to Order at 7:00 PM with the Pledge to the flag.

Agenda: Don Tracey made the motion to approve the April 2026 Meeting Agenda, supported by Cheryl Dotski. Motion carried.

Approval of Minutes: Don Tracey made the motion to approve the March 2026 Regular Meeting Minutes, supported by Cheryl Dotski. Motion carried.

Payment of Bills: Cheryl Dotski made the motion to pay the April 2026 bills in the amount of \$8,681.7, supported by Don Tracey. Motion carried.

Updates: Fire Board: Meeting cancelled. MTA: MTA legislative updates. Cheboygan County Road Commission Meeting: No update.

1st Public Comment: Joseph Long, a resident of Grant Township, Michigan, spoke in detail in regards to the Munro Solar Project. At the current time there are 13 landowners in the Township of Munro contemplating or have signed a lease of their farm land to Consumers Energy for a 1900-acre industrial solar project. Mr. Long touched on subjects to include the hidden negative tax and environmental consequences. He also spoke to the recent Moratorium signed by the Cheboygan County Board of Commissioners and ruling by 53rd Circuit Court Judge Aaron Gauthier. Unfinished Business: Afton Stone per ton delivered/\$35,00.00 total: Three bids for the Afton stone were submitted: 1) Cheboygan County Road Commission at \$16.90 per ton, 2) EF Wilkinson at \$18.29 per ton and 3) Darrow Brothers Excavating at \$17.85 per ton. Motion by Don Tracey supported by Cheryl Dotski to award the bid to the Cheboygan County Road Commission at \$16.90 per ton of delivered Afton Stone. Upon roll call the following voted aye: Bur, Dotski, Antkoviak and Tracey. Voting nay: None. Absent: Ginop. Motion Adopted.

New Business:

- **Cheboygan County Humane Society:** Motion by Mary Bur, supported by Don Tracey to submit a \$400.00 payment to the Cheboygan County Humane Society for services rendered. Upon roll call the following voting aye: Bur, Dotski, Tracey and Antkoviak. Voting nay: None. Absent: Ginop. The Motion is Adopted.

- **Certificate of Deposit:** Motion by Supervisor Ginop supported by Don Tracey to move \$200,000.00 from the general savings into CD's at CNB (Treasurer Dotski did the research to obtain interest rates from several local banks). \$100,000.00 is to be placed in 12-month CD's and the other \$100,000.00 into 9-month CD's. This money will be used for future road projects. Upon roll call the following voted aye: Bur, Dotski, Ginop, Tracey and Antkoviak. Voting nay: None. The Supervisor declared the Motion Adopted.
